

## **Rosendale Town Board      Budget Meeting      November 21, 2017**

The 2018 Budget Meeting of the Rosendale Town Board was held on November 21, 2017 at the Rosendale Town Hall. The agenda for this meeting was posted at the Town Hall on the bulletin board and front door, Shorties Sports Bar & Grill, and on the town website [www.townofrosendalewi.com](http://www.townofrosendalewi.com).

The meeting was called to order by Supervisor Goeden at 7:00 p.m. Supervisor Matthew Zimmerman as well as Clerk/Treasurer Roxanne Tarnow were present. There were 3 electors, and 0 guests present. A motion was made by Cindy Pierstorff and seconded by Steve Fairbank to approve the agenda. Motion carried (3 ayes, 0 nays, 0 abstain and 0 not voting).

Clerk Tarnow presented the 2018 Town Budget. Supervisor Goeden asked for any discussion concerning the proposed 2018 budget. There was some discussion as to why some of the money totals were either higher or lower than last year's budget. It was explained that some of the totals were estimates from vendors and at year-end these totals were adjusted depending on the bills. With no further questions, Supervisor Goeden asked for a motion to accept the proposed 2018 Town Budget. A motion was made by Steve Fairbank and seconded by Cindy Pierstorff to accept the proposed 2018 Town Budget as presented. Motion carried (3 ayes, 0 nays, 0 abstain, and 0 not voting).

A motion was made by Mike Nickoli and seconded by Steve Fairbank to adjourn the Budget Meeting. Motion carried (3 ayes, 0 nays, 0 abstain, and 0 not voting).

Supervisor Goeden called to order the Special Town Meeting following the Budget Meeting to accept the 2018 highway expenditures. Highway expenditures for the township are estimated to be \$161,635.00. A motion was made by Steve Fairbank and seconded by Cindy Pierstorff to accept the proposed 2018 highway expenditures. Motion carried (3 ayes, 0 nays, 0 abstain, and 0 not voting).

A motion was made by Cindy Pierstorff and seconded by Mike Nickoli to adopt the 2018 Town of Rosendale levy of \$219,411.00 to be paid in 2018. Motion carried (3 ayes, 0 nays, 0 abstain, and 0 not voting).

A motion was made by Steve Fairbank and seconded by Mike Nickoli to adjourn the Special Town Meeting. Motion carried (3 ayes, 0 nays, 0 abstain, and 0 not voting).

The meeting duly adjourned at 7:10 p.m.P
